

THE SCIENTOLOGY CONGRESS in Washington, D.C. on January 1, 2 and 3, 1960 was one of the most warmly received Congresses ever held. This Congress marks the turning point of Scientology in the United States. In his lectures, Ron described the complete new technical front, based not so much on new materials as on a wider understanding of the older data, which was initiated in the First Melbourne ACC last November. It is sufficiently startling in its approach and effectiveness to give new confidence to every Scientologist.

In the first unit of the Hubbard Clearing Scientologist course these new techniques have been taught. In subsequent HCS units, more students will have the opportunity to become proficient in their use.

Definitions

A CLEAR: A person at willing and knowing cause over his own life, his environment and his surroundings and without a reactive or a subconscious mind.

A THETA CLEAR: A clear who can create or uncreate a reactive or subconscious mind at will.

AN OPERATING THETAN: A person who is at knowing and willing cause over matter, energy, space, time, life and form.

These states of being can be achieved with Scientology processing.

Your best guarantee of ethical and expert auditing is a prominently displayed HCO Franchise. Your Central Organizations cannot guarantee the ethics of all auditors but those who hold HCO Franchises are known to be ethical. In case of doubt about your auditor's record write to your Organization Secretary. She can inform you of the standing of any practicing Scientologist. You can also write to your HCO Secretary concerning any matters of ethics, technology and awards.

Responsibility

by L. Ron Hubbard

If the definition of Operating Thetan is knowing and willing cause over all dynamics then we can see at once that responsibility must go hand in hand with making an Operating Thetan.

One cannot as-is* acts for which one is taking no responsibility, but for which one is really responsible.

The reason one gets amnesia on his past lives or even denies their existence lies with responsibility. He or she is unwilling to take responsibility for having been this or that other identity. This keys in in present time and closes one down every time one stops taking responsibility for one's fellows. Fighting "other identities" in present time one ceases to be responsible for other identities. Therefore those he has had in the past become "other people" and one dramatizes his own past identities because he cannot take responsibility for them.

When one falls away from responsibility on the various dynamics he can then become less and less able to influence those dynamics and therefore becomes a victim of them. One must have done to other dynamics those things which other dynamics now seem to have the power to do to him. Therefore one can be injured. One can lose control. One can become in fact a zero of influence and a vacuum for trouble.

The way one becomes separate from others is by his own overt acts against them. These overt acts become withholds and the person then individuates very strongly. You have seen this happening in auditing. The more overt acts the auditor pulls on the pc the less willing the Auditor is to audit that pc. Further, the more overt acts the pc pulls on the Auditor the less willing he is to stay in session. It only looks as though cause and effect is at work. Actually all life consists of opposed causes where it is aberrated.

The way a person blows out of session or blows out of an organization or blows out of Scientology is a simple one. He withholds information and hides his overts. After a while he blows himself off. Show me a pc blowing session and I will show you a pc who has not leveled with his Auditor and who is guilty of undeclared overts against the dynamics and the auditor. Show me a staff member who is blowing the Organization and I will show you a staff member who is guilty of undeclared overts against the Organization.

It is fatal to audit anyone unless full two-way communication is established between the auditor and the pc. The person who goes on being audited without asserting his responsibility for what he has done is a person who will make no auditing gains or whose auditing gains will slump. As most of the human race has undeclared overts this fact alone assumes gigantic proportions in forwarding Scientology and for that reason alone we will have to give it a lion's share of attention from here on out.

Of course you will see that many people at first will not come near us for fear of what we will find out. But as this is better understood you will find that the people who come to us will come with a willingness to bare their guilt to us and get it sorted out.

As this is so much the case we must then therefore have amongst us none with undeclared overts against the dynamics which would prevent their getting gains in processing or who would render a person's confidences liable to use for less pure purposes.

Along with this technical discovery then goes the administrative must that our noses must be clean and our hearts cleared. Our strength will be the strength of a billion if we have nothing to hide.

This may or may not be popular. I don't care about that. It is effective. I do care about that.

And remember that whenever a person discloses to view discreditable overts and witholds we must run what part of that act or incident could you be responsible for.

You're going to see more case gains than you've ever seen before - providing you have the stamina to get over this first hump.

So here we change from irresponsible to responsible, from guilt to strength and all in the twinkling of an eye.

This is the new beginning of Scientology.

THE HCA CERTIFICATE

The HCA - Hubbard Certified Auditor - certificate is the oldest Scientology certificate and is the first and foremost of the certificates entrusted to trained practitioners of Scientology. There are senior certificates and degrees above this certificate, there are also certificates below it. The HCA certificate, nevertheless, is the prime certificate issued to Scientologists. It indicates to the public at large that the holder has been trained as an auditor in Scientology procedures and practice.

The HCA certificate is not easy to obtain. The exacting requirements must be met to the full satisfaction of the HCO Board of Review and the Academy and the other departments concerned.

To show you the care which goes into the issuance of an HCA certificate, we print a brief synopsis of the HCA requirements:

1. The candidate must attend, and complete each week satisfactorily, the eight weeks of training at the Academy.
2. An examination based on the material covered during the course, plus the Axioms, Logics and Prelogics of Scientology, must be taken and passed to the satisfaction of the HCO Board of Review. In this examination great stress is placed upon the candidate's ability to establish an auditing environment for his preclear and maintain that environment smoothly regardless of difficulties created for him by the preclear or other factors. This examination is very stiff indeed.
3. The HCA Extension Course must be completed in full to the satisfaction of the Extension Course Director.
4. The candidate must pass the standard set for teaching a PE course and running an HAS Co-Audit to the satisfaction of the Director of the Personal Efficiency Foundation.
5. An International Membership in the H. A. S. I. must be taken out by the candidate.
6. The account for the HCA training at the Academy must be paid in full.
7. All reports and infraction theses due must be handed in and passed upon by the instructor of the course the report or thesis is due on, or by the Director of Training.
8. Student must send in three case histories of preclears he has audited through to the state of release.
9. Student is able to recognize and produce the four basic needle reactions on an E Meter. And more importantly, is able to assess a case with an E Meter.

When all of the above items are completed, the certificate will be made out and sent to L. Ron Hubbard for his signature.

Receipt of the certificate, signed by L. Ron Hubbard, now establishes the candidate as a graduate of the Academy and as a certified auditor. The new auditor is now eligible to apply for a Franchise from the Hubbard Communications Office, the purpose of which is to get a smooth communication line running be-

tween the field auditor and Ron, who is directly represented by HCO. The franchised auditor is kept supplied with up-to-the-minute technical data in the form of Bulletins, can write in to HCO for advice on dissemination and technical problems, receives a 40% discount on his book and tape purchases, and other services. In return the auditor pays 10% of his weekly earnings from Scientology - this money is used to enable Ron to continue his Research work and covers mailing costs.

There are two types of Franchises. The first is for running HAS Co-Audits as well as individual processing practice. The second permits an individual auditor to run an individual practice or guidance center without running a HAS Co-Audit.

Having obtained a certificate and a franchise, the auditor must continue to fulfill the high ethical standards of the professional Scientologist in order to retain them.

While to this time there is no definite time limit in which all of the requirements for the HCA certificate must be completed, it is very probable that a time limit will be set for this in the near future. Such time limits have existed for students on an Advanced Clinical Course, which is an HCO course; the purpose being to doubly ensure that a candidate for a certificate does not adopt a negligent attitude toward certification and to make sure that every candidate wastes no time in completing the requirements.

A certificate received prior to 1957 can be validated by the holder taking a validation course and passing the HCO Board of Review examination on the CCH's. Validation can also be achieved by successful completion of an ACC. A gold seal on a certificate signifies that the holder is able to teach validation in the field. A red seal signifies training on the CCH's by a Central Organization. A blue seal means the holder of the certificate has received validation training from a gold seal holder in the field.

An HCA certificate, dated or validated within the past two and one half years, is a clear advice to the public that "this person is a trained Scientology auditor and has the confidence of L. Ron Hubbard as a Scientology auditor".

No profession on Earth places greater emphasis on good ethics and good training than does Scientology: an HCA certificate is a written testimonial of the good training and the good ethics of the person named on the certificate.

The above information we hope will serve to show you that an HCA certificate is not come by in a casual or disinterested manner.
