Successful Training Lineup

It has recently been found that there are blocks to Academy and major course training which are slowing the training of Auditors and C/Ses. It has been additionally found that the erroneous requirement of BSM before Academy contained in the above HCO PL had introduced a training cutative by taking the Student Hat and Study Tapes out of the training line-up.

It is well known that these materials have been the backbone of Scientology training since their introduction in 1964. They are therefore fully reinstated by this BPL.

The basics of successful training are simply the basics of Standard Study Tech. This means fast courses that encourage more enrollment and that produce Auditors and C/Ses and Supervisors who really know and apply Standard Tech.

Further, staff training is itself vital in an org. is a matter of survival to an org to be able to train its staff quickly.

STAFF TRAINING AND HATTING

The only prerequisite for Staff Hatting is BSM done per the checksheet. PRD is not a prerequisite, nor is a Student Hat nor is Word Clearing Method 1. Where a staff member has had neither the PRD nor M1, he may not fast flow his hatting, but may only starrate check out, and take exams to graduate.

Where a staff member has had PRD or Student Hat and Method 1, he may fast flow his hatting with no twin checkouts, no examination, but only by attest.

Staff training on Major Tech or Admin courses is as given later in this BPL. Staff training on major admin courses has prerequisites as follows: for OEC a staff member must do a full Student Hat and Method 1 and may then fast flow the course; for FEBC, the PRD in full is prerequisite.

It is important to note the difference between staff HATTING and staff TRAINING. For an exact outline of the basic sequence of hatting, see HCO PL 24 July 72, Esto Series 23, "The Vital Necessity of Hatting".

FAST FLOW TRAINING RULES

Following are the rules of Fast Flow Training:

- 1. The only prerequisite for a student, staff or public, to be able to Fast Flow his courses is Student Hat and Method 1 Word Clearing. Where a student has already done the full Primary Rundown, he is also qualified to Fast Flow his courses.
- 2. Requirements of twin training or checkouts for Academy are suspended.
- 3. The prerequisites for Major Courses and Academy training are Student Hat and Method 1 Word Clearing. BSM as an Academy prerequisite is abolished.
- Where a student has not yet completed his Method 1
 Word Clearing, he is not to be held up or denied his
 Academy Courses or put onto smaller courses, but may
 get on with his Academy doing Starrate Checkouts and
 examinations to graduate while completing M1.
- The Student Hat Course including Study Tapes is one time only FREE and MANDATORY for any Major Course.

 (Note: A full Academy Package 0-IV must be purchased in order for this offer to be applicable -- not just individual levels.)
- 6. Method 1 Word Clearing must be fully done with each word taken to F/N as well as F/Ning the final assessment.
- 7. Method 1 may be done either on a Student Co-Audit or in the HGC. If purchased in the HGC, professional rates apply for those students who have purchased the full Academy O-IV. If done on a student Co-Audit,

the Method 1 Co-Audit Course must be completed and is free for those students who have purchased the full Academy O-IV.

- 8. The above rules apply to OEC training.
- 9. The above rules apply to AOs and SHs.
- 10. Method 1 Word Clearing is not a prerequisite for HSDC or HPDC, but is advised.

FAST FLOW AND QUAL

Students who graduate Academy training Fast Flow are not made to take examinations. Courses are passed by attestation at C&A that the student has: (a) enrolled properly on the course, (b) paid in full for the course (or has signed a no charge invoice in the case of 2½ or 5 year contracted staff), (c) studied and understands all the materials on the checksheet, and (e) can produce the result required in the materials of the course.

Interneships and High Crime Checkouts requirements remain as issued. High Crime Checkouts and cramming actions requiring starrates are done starrated and not fast flow.

Interneship graduation requirements are that a full Interneship as formal auditing experience is completed. When actual honest evidence is presented to C&A that a student has demonstrated that he can and has produced flubless results, the Interne's Certificate is validated and made permanent. Until an Interneship is completed as above, Academy certificates are PROVISIONAL.

With other courses the person must demonstrate that he can apply the materials studied by producing an actual statistic in the materials studied, such as an Apprenticeship done in full. This evidence is presented to C&A and the student receives a validation gold seal, making his certificate permanent.

Qual has the responsibility of safeguarding the technology. Qual must be very strong to fulfill its responsibility, especially under Fast Flow training. Ethics must be accurate and not neglected. Ethics exists to get Tech in.

FALSE ATTESTS on Fast Flow get immediate cancellation of certificate and a Condition of Doubt.

A Provisional Certificate expires one year from date of graduation if not validated. Persons whose provisional certs have expired are required to take an Interneship for their past Class levels, at which time if Interneship is successfully passed, a Permanent Cert is awarded.

CLASS VII

Class VII is a vital level for training Sea Org Auditors. Orgs should have at least 2 Class VIIs on 5 year contract to deliver Power to contracted staff.

Class VII is not prerequisite for Class VIII. The Class VII Course is not now available for public, but may be delivered to Org Auditors on a valid and proven 5 year contract, and to Sea Org Auditors only.

IMPORTANCE

The importance of top notch, 100% Standard Training on Academy and higher level Tech and Admin training courses cannot be stressed enough. The foundation of this is strong, Standard Study Tech. Auditors and C/Ses and Supervisors and Executives who have not gotten in firm Study Tech basics have been seen to fail time & again & to themselves be sources of out-tech, declining delivery and declining income.

Full Study Tech is hereby going back in with a crash. Staff only are allowed to do BSM as a hatting prerequisite and that is only a study boost, not a full grounding in Study Tech. BSM may, of course, be sold separately, but does not fulfill any study requirements except for staff hatting or public mini courses.

The full technology of Dianetics and Scientology is there to be duplicated and applied. Please see that it is.

The Student Hat course was put back onto the Training Route several months ago by LRH when it was discovered that the course had disappeared from use.

Following is a quote from LRH HCOB 24 Jan 77 TECH CORRECTION ROUND-UP on recent LRH discoveries on Study Tech:

"During an investigation of pricing I discovered that 'The Student Hat' had disappeared from use and in its place had been put an optional 'Basic Study Manual'. The fact is that the Basic Study Manual has its own uses and is very valuable but it does not begin to replace The Student Hat."

This meant actually that study tech had more or less disappeared in Academies and was not in general use.

The actions taken were to make the Student Hat mandatory on a one time basis before the next major course a person took and to include it free as a bonus to the person taking that course.

The Student Hat has been restored in totality as a requisite for study tech. This will make study much more positive and much faster.

The Basic Study Manual was put forward some time ago as a means of getting staffs hatted on their hat material and as a fast method of getting people reading the materials of their posts. I suppose that is how it drifted over onto major courses, where it has no business.

Thus the Student Hat is back full force and if there are any blown students around you should realize that the reason for their blow is either lack of study tech or undisclosed overts. The thing to do is to get them back and

mush them through the Student Hat so they can win at their striles and get their overts off so they can look their fellow man in the eye.

"There has been another training outness found which I will mention in passing. In some interneships, the entire Oual staff of the org has been employed in checking out students. Actually such checkouts are done by students themselves, on each other where starrates are resulted in interneships.

"It has also been found that twinning in theory occasionally creeps back in. People have not noticed that twinning on theory, meaning two students always study together, went out many years ago and has been cancelled. It makes a noisy classroom and prevents students from getting through their courses rapidly. Twinning on theory sets up too many difficulties such as the loss of one's twin by reason of graduation or transfer, being sent to cramming, an odd number of people on the course so that one is without a twin and so on.

"Practical is another matter. In Practical drilling is done on the twir basis.

The theory and practical are never in the same room; they must be in different rooms. The theory room must be very, very quiet where a student can concentrate and the practical room must be so situated as to allow students to make noise. If any Academy has a noisy theory class-room or if the Academy is difficult to study in, this is probably what is in violation: probably the twinning is going on in Theory or the theory rooms are noisy. Only a practical room can be made noisy.

1. The only prerequisite for a student, staff or public, to be able to Fast Flow his courses is Student Hat and Method 1 Wordclearing. Where a student has already done

the full Primary Rundown, he is also qualified to Fast Flow his courses.

- 2. Requirements of twin training or checkouts for Academy are cancelled.
- 3. The prerequisistes for Major Courses and Academy training are Student Hat and Method 1 Word Clearing. BSM as an Academy prerequisiste is abolished.
- 4. Method 1 Word Clearing must be fully done with each word taken to F/N as well as F/Ning the final assessment.
- 5. Method 1 may be done either on a Student Co-Audit or in the HGC. If purchased in the HGC, HGC rates for Ml apply per HCO PL 13 Nov 76 PROFESSIONAL RATES. All Wordclearing materials have been added to Level 0 Academy and students can easily receive their Method 1 Wordclearing at that level if not yet received on a co-audit basis). Supervisors are forbidden to prohibit co-auditing on Method 1. It's important that students do receive this wordclearing.
- 6. A Drug RD is not necessarily a prerequisite to Method l Wordclearing. Where a drug case cannot be gotten through Method One Wordclearing due to case, it is usual to give him the Drug Rundown first. The student may receive his Drug RD on a co-audit basis or purchase it in the HGC.
- 7. Where a student has not yet completed his Method 1 Word Wordclearing, he is not to be held up or denied his Academy Courses or put onto smaller courses, but may get on with his Academy doing Starrate Checkouts and examinations to graduate while completing M1.
- 8. The only prerequisite for Staff Hatting is BSM done per the checksheet. PRD is not a prerequisite, nor is a Student Hat nor is Wordclearing Method 1. Where a staff member has had neither the PRD nor Method 1, he may not fast flow his hatting, but may only starrate checkout, and take exams to graduate. Where a staff member has had PRD or Student Hat and Method 1, he may fast flow his hatting with no twin checkouts and no examination.

FAST FLOW TRAINING RULES

FAST FLOW DEFINED

A student attests his theory or practical class when he has fully covered the materials and can apply them. There is no examination. (LRH ED 2 INT)

The fast flow student passes courses by an attestation at Certs and Awards that he a) enrolled properly on the course, b) has paid for the course (or signed a no-charge invoice for 2½ or 5 year contracted staff), c) has studied and understands all the materials on the checksheet, d) has done the drills called for by the checksheet, e) can produce the result required in the course materials. Twin checkouts are suspended. Examinations are not required.

Following are the rules of Fast Flow Training:

- 1. The only prerequisite for a student, staff or public to be able to Fast Flow his courses is Student Hat and Method 1 Wordclearing. Where a student has already done the full Primary Rundown, he is also qualified to Fast Flow his courses.
- 2. Requirements of twin training or checkouts for Academy are cancelled.
- 3. The prerequisite for Major Courses, the New Era Dianetics Course and Academy training is Student Hat. ... BSM as an Academy prerequisite is abolished.
- 4. Method 1 Word Clearing must be fully done with each word taken to F/N as well as F/Ning the final assessment.
- 5. Method 1 may be done either on a student co-audit or in the HGC. If purchased in the HGC, HGC rates for M1 apply per HCOPL 13 Nov 76 PROFESSIONAL RATES. Students can easily receive their Method 1 Wordclearing by taking the NEW WORD CLEARING CO-AUDIT COURSE and co-auditing their Method 1. This step is recommended before starting level 0. Supervisors are forbidden to prohibit co-auditing on Method 1. It's important that students do receive this wordclearing.
- 6. There are no auditing prerequisites to receiving Method 1 Wordclearing. Where a drug case cannot be gotten through Method 1 Wordclearing due to case, it is necessary to put him on the New Era Dianetics Full PC Program Outline and get him through his Drug Rundown first. The student may receive New Era Dianetics auditing on a co-audit basis or purchase it in the HGC.
- 7. Where a student has not yet completed his Method 1 Wordclearing, he is not to be held up or denied his Academy Courses or put onto smaller courses, but may get on with his Academy doing examinations at the end of each level to graduate, while incomplete on his Method 1.
- 8. The only pre-requisite for Staff Hatting is BSM done per the checksheet. PRD is not a pre-requisite, nor is a Student Hat nor is Wordclearing Method 1. Where a staff member has had neither the PRD nor Method 1, he may not fast flow his hatting and must take exams to graduate. Where a staff member has had PRD or Student Hat and Method 1, he may fast flow his hatting with no examination.
- 9. False attestations on Fast Flow Training equals a condition of Liability for the student, and immediate cancellation of the cert, and loss of Fast Flow Training privileges.

- 10. Students who have completed the PRD (Superliterates) are not required to do all the clay demos called for on the checksheet, but must do all of the drills. If they have studied the material on a previous checksheet, they are not required to restudy the material. Superliterate students must ensure that they are studying with a proper balance of mass and significance and are subject to pinksheets on this by supervisors if they do not.

Practical, TRs and meter drills are always done when called for on a checksheet despite having been done before.
